Opening

Joel handed out a PLI Board Conduct and Expectations document which outlined his thoughts on board member behavior (attached). Discussion: General agreement on the document was expressed. Follow on discussion on how to deal with difficult people during games and other interactions. No action or follow-up on handout needed.

GENERAL TOPICS

Board Updates:

- Brief interview of Jamie Greenwood for Board of Directors
- Discuss options for treasurer position and Mike Magnuson assistance. Joel has reached out to a couple of individuals about coming onto the board as Treasurer but no luck so far. Stefan agreed to bring data from Mike Magneson to the Board and act as a liaison on a temporary basis.

Tournaments

• May Day Melee Tournament Update expected numbers of players etc. (Joel). 106 participants as of now. Bill will cross check to see how many participants are PLI members. Sunday is loaded as far as participants.

Bill volunteered to do a survey on PLI member's attitude on tournaments. Discussion about competitive versus recreational play as well as leagues. Bill will work on survey draft.

• Discuss Summer Tournament schedule (Bill). The tournament schedule was ratified as discussed above.

Maintenance and Upkeep

• Addition of Densmore Park for our use, adding lock box, painting lines (Joel) Joel will email licensing agreement with LPRD to all. This year will add 4 PB courts and lockbox at Densmore park. There are parking issues on weekends with soccer / softball / baseball. LPRD has asked PLI to not use PTS for scheduling to start due to parking concerns. Roberts Park will be used by Tennis for 6 weeks this summer and PLI scheduled activities will move to Densmore during this time. Bill will find other ways than PTS to provide information to attendees per LPRD's request.

Fundraising:

- Square Festival booth on 5/24 (Sasha) Wednesday 10-2. Jen and Stefan will help. Need to provide our own table and chairs.
- Give to Lincoln Day fundraising update and match donations (Joel). Check for email from Joel about Give-to-Lincoln
- Campaign and marketing through new paid version of Mailchimp (Joel) Need to start paying a fee for Mailchimp Program in order to access desired features. Cost is

\$27-28/month and is currently being paid for personally by Joel. No action on PLI covering cost was taken.

Joel:

• Summary of License Agreement with City. LPRD has agreed that PLI can collect funds for clinics, and other solicited donations at satellite courts. LPRD will create a webpage and QR code link to allow people to donate directly to the parks foundation endowment. Discussed potential lease agreement with LPRD on Jensen Park for possible PLI stand-alone facility. Expanded PLI programming on satellite courts to five days per week Need to stress PLI members being on being kind friendly. PB is now on an equal footing with baseball / tennis / etc. We are now considered "a basic level of service" by LPRD.

Bill: does LPRD pay for nets at tennis courts? Thinking about Peterson Park PB nets. Jen Stai reached out via text in real time to a contact at LPRD and answer was YES, LPRD does pay for tennis net repairs / replacements.

Stefan:

 - Tower Square festival
 - PLI member spotlight: Mirriam Walker

Cindy:

Brought up issue as to whether we should have an additional PTS administrator who is a board member. Bill noted that he is a PTS admin as well as Doug Marthaler, Jane Cech and Brent Dickie. Discussion occurred regarding differences between Lincoln and every other geographic area in the US. Lincoln is "locked" in that the general public cannot use PTS to organize court time whereas other areas are wide open. The exception to this is that invite only RR coordinators (who are not admins) can schedule their own RR's. Discussed pros and cons of our approach.

Action Item: Bill will talk to Doug Marthaler about adding additional admins as well as how PTS is currently set up regarding allowing RR coordinators to schedule their own RR's.
