








# Proposed Changes to Playtime Scheduler Color Organization

The current organization doesn't account for how people interact with the courts in Lincoln. For example, the same open play designation is used for courts across town (the 5 City parks). Without memorizing the map or court names, there is no way to organize for what is convenient or close to any player.

The two primary organizations should be

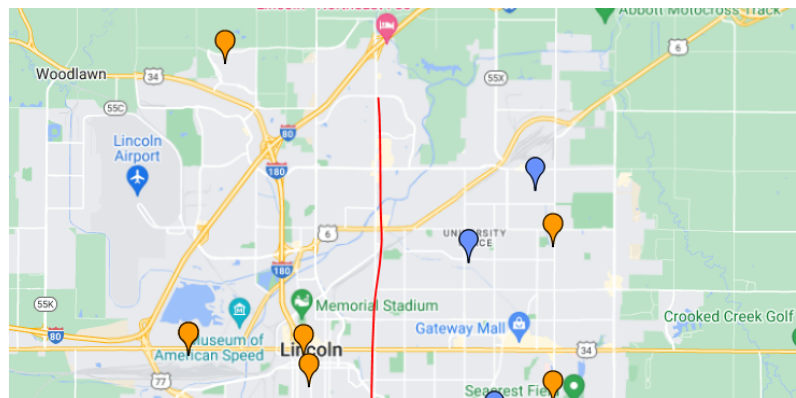
1. What people want to do:
  - a. If someone wants to play in a tournament or drills, they are willing to drive to the event
2. Where the court is in Lincoln:
  - a. If someone just wants to play, they want something close to their house and convenient

The layout should reflect these two principals. Unfortunately, there are only 10 pre-chosen colors available. Thus, labels should both determine type and location as efficiently as possible.

## **Membership Terms and Conditions**

**Waiver, Assumption of Risk & Release of Liability Waiver.** By participating in PLI activities and events I, for myself, my heirs or assigns, do hereby release, waive, discharge PLI, its directors and officers, volunteers, and members from liability and all claims resulting in personal injuries, accidents or illnesses (including death) and property loss arising from, but not limited to, participation in PLI activities and events.

**Assumption of Risk.** Participation in PLI activities and events carries with it certain inherent risks that cannot be eliminated regardless of the care taken to avoid injuries. The specific risks vary, but include minor injuries such as bruises, sprains and dehydration; major injuries such as eye injuries, joint or back injuries, heat stroke, heart attacks, and concussions; and catastrophic injuries such as paralysis and death. I have read this assumption of risk and I know, understand and appreciate these and other risks that are inherent in playing pickleball. I assert that my participation is voluntary and that I knowingly assume all such risks.

**Indemnification & Hold Harmless.** I also agree to indemnify and hold PLI and its directors and officers, employees, volunteers, and members harmless from any and all claims, actions, suits, costs, expenses, damages and liabilities, including attorney's fees brought as a result of my involvement with PLI.

**Marketing & publicity.** I agree that to further the mission and current and future goals of PLI marketing and publicity will be used by PLI and I consent to the use of my name, image, and likeness without compensation or further consent in various publications including the PLI annual report, public

membership roster, and other forms of media including public and social media available now or in the future.

**Code of Conduct.**

I agree to follow this code of conduct as a condition of membership in PLI and understand that membership can be denied or revoked for serious or repeated violations of the code of conduct.

- Treat fellow PLI members with respect and demonstrate and encourage sportsmanship

## Form Fields
